# What is a document?

### A document is a written letter or a printed letter signed by the competent authority as evidence.

Article 1 Paragraph 1 Minister of Foreign Affairs Regulation Number 13 of 2019 on Procedures for Legalization of Documents at the Ministry of Foreign Affairs



Documents can be in the form of data, recordings, or information that can be seen, read, and/or heard that can be issued with or without the help of a means, whether written on paper or any physical object other than paper or recorded electronically, including but not limited to:



<u>text, sound, or image;</u>

<u>maps, designs, photographs, or the like; ann</u>







LEGAL USAGE OF FOREIGN MADE DOCUMENTS



THE APPLICATION FOR LEGALIZATION IS SUBMITTED BY THE APPLICANT THROUGH ELECTRONIC REGISTRATION IN THE MINISTRY'S LEGALIZATION APPLICATION.

THE REGISTRATION CAN BE DONE THROUGH:

a. FILLING OUT THE APPLICANT IDENTITY DATA ON THE REGISTRATION FORM; b. CREATE KEYWORDS; and c. UPLOADING IDENTITY CARD PHOTO.

#### **REQUIRED APPLICANT IDENTITY**

a. NAME b. IDENTITY CARD NUMBER; and c. PHONE NUMBER; and c. ELECTRONIC MAIL ADDRESS

AFTER GETTING THE ACCOUNT, THE APPLICANT SUBMITS A LEGALIZATION APPLICATION BY:

a. FILL OUT THE APPLICATION FORM; b. UPLOADING DOCUMENTS TO BE LEGALIZED; c. UPLOADING PART OF DOCUMENTS THAT CONTAINS LEGALIZATION; d. SIGNING THE STATEMENT OF RESPONSIBILITY FOR THE ACCURACY OF APPLICATION FOR LEGALIZATION AND USE OF DOCUMENTS RESULTING FROM LEGALIZATION.
